It was a real pleasure to receive the letter from GEORGE ALBERT GLADNEY of the Missouri branch of the Gladney family tree. He wrote, "Dear William...This is in reply to your letter of March 25, 1985. Sorry for the long delay in writing, but I wanted to show my sister the material you sent on GIAFA. My sister, MARY ELIZABETH GLADNEY CALDWELL, lives in Fayetteville, Arkansas, and I am visiting with her in Fayetteville at this moment. We are both delighted to know about GIAFA and enclosed is a check for \$20.00 to cover annual dues for myself and my sister...The following information should bring GIAFA up to date on my immediate family: As noted in the Gladneys In America genealogy/family history book, my father, DAVID CLARK GLADNEY (s/o Albert Caldwell Gladney and Mary Duncan Gladney, P.98-GIA) was born Oct. 12, 1909 and was a descendant of the Richard Gladney line. My father was born in Moberly, Mo.; he died Nov. 29, 1968 in Pittsburgh,

Pa. The genealogy book lists his residence as Sumatra. He did, in fact, live in Sumatra (the Republic of Indonesia) as a pipeline engineer for Standard Oil Company of New Jersey in the late 1930's. Shortly before his death he retired from the Blaw-Knox Company of Pittsburgh, Pa. A full obituary is enclosed. My mother, MARY FRANCES GOWEN GLADNEY, was born Jan. 14, 1913 in Caruthersville, Mo. and married my father on Sept. 22, 1935 in Caruthersville. She is a retired schoolteacher and presently lives at 834 East Ash, Fayetteville, Ark. 72701. My sister, MARY ELIZABETH GLADNEY CALDWELL, was born Jan. 20, 1942 in Wilmington, Delaware. She presently is a certified public accountant and teaches business courses at the University of Arkansas in Fayetteville. My sister has two daughters, SARA ELIZABETH CALDWELL, born Oct. 13, 1969 in Cleveland, Ohio, and CLAIRE CATHERINE CALDWELL, born Mar. 29, 1973 in Fayetteville, Ark. The father, CHARLES W. CALDWELL, is a professor of electrical engineering at the University of Arkansas; the two children are in public school. As for myself, I was born GEORGE ALBERT GLADNEY on Sept. 24, 1946 in Wilmington, Delaware. I graduated from the University of Missouri school of journalism and have been in the newspaper business for 14 years. Currently I am managing editor of the Jackson Hole News in Jackson, Wyoming ... I read with interest the Gladney-Grams letter dated 4+13-85 from ENID CHANDLER BARNES of St. Louis, Mo., referring to information about early Gladneys in Missouri, particular reference to the Gladney Cemetery in Lincoln County. If I am not mistaken this is the same cemetery where I witnessed the burial of my father's mother, MARY DUNCAN GLADNEY, who was born Sept. 4, 1877 and died Oct. 21, 1970, at a cemetery in or near Olney, Mo. I believe this is the same cemetery that her husband, ALBERT CALDWELL GLADNEY and other son, ENOCH ALEXANDER GLADNEY, were buried. This cemetery must be actually in what is called Auburn, Missouri, since material I have says that ALBERT CALDWELL GLADNEY was buried in Auburn. As you can see, I am a little unsure of this... Incidentally, my father's mother, MARY DUNCAN GLADNEY, did a lot of work professionally as a genealogist I believe in the 1930's and 1940's and one of the papers I found (see enclosed) is the genealogy of my father. It is entitled "Dedicated to Descendants of Richard Gladney and Jennett (Jane) Wilson his wife, compiled by Mary Duncan Gladney, 1931." With it is attached the will of Jennett (Jane) Strong Gladney, a copy of which I sent to WILLIAM LOVVORN GLADNEY of Bremen, Ga. and which I believe he sent on to you ... This is about all I have at the present, although we have numerous letters and other correspondence. I notice among all this some post-cards sent from a J.S. GLADNEY in 1910 from Columbia, SC to my grandfather, A.C. GLADNEY, in Moberly, Mo. Interesting that the Gladneys In America family reunion is in same city of Columbia. I am sorry that none of us will be able to attend. Living up in Wyoming, I feel fortunate enough just to get down to Arkansas now and then... Limens of the complete seem many a pro-growth /s/ George."

George, let me express my appreciation for the material enclosed with your letter. For your information, the J.S. GLADNEY of Columbia, SC, who wrote the postcards in 1910 to your grandfather, ALBERT CALDWELL GLADNEY, was most probably JAMES SHIELDS GLADNEY (1854-1920)...see P.57-GIA. Surely, the daughters of JAMES SHIELDS GLADNEY - MRS. CHURCH W. CARROLL (nee Annabelle Gladney) of York, SC and MRS. THOMAS LEONARD HOSALL (nee Sara Fitzpatrick Gladney, D.A.R.) of Atlanta, Ga. - were the Gladney descendants who corresponded with your grandmother, MARY DUNCAN GLADNEY, many years ago...see P.57-GIA also.

Gladney Services Held Today... Retired Engineer Worked On Several Nuclear Projects . . Services for DAVID C. GLADNEY a retired chemical engineer who worked on several pioneering nuclear projects, were held today at the E.B. Laughlin Funeral Home, 3310 W. Liberty Ave. .. Mr. Gladney of 490 Mapleton Ave., Mt. Lebanon, died Thursday at Magee-Womens Hospital ... He served in an executive capacity with the Manhattan Project for the development of the atomic bomb during World War II and for the E.I. duPont De Nemours and Company. Mr. Gladney also worked as a power design engineer on the AEC H-bomb project...He was general works manager with the Chapman Valve Mfg. Co. of Massachusetts from 1952 until 1960 when he joined the Blaw-Knox Co. of Pittsburgh...Mr. Gladney was construction superintendant of Blaw-Knox's chemical plant division when he retired. . A graduate of the Univ. of Missouri and Western New England College, he was a member of the South Minister Presbyterian Church, Mt. Lebanon, the Masonic organization, Royal Order of Jesters and the American Society of Chemical Engineers. . Surviving are his wife, Mrs. Mary F. Gladney; a daughter, Mrs. Charles W. Caldwell; a son, George; and his mother, Mrs. Mary Duncan Gladney ... The family suggests contributions to the Allegheny County Chapter of the American Cancer Society...Burial was in Mt. Lebanon Cemetery. Tex helpolines, tropsoid at agentalo place

OBITUARY information on FRANKLIN YOUNG GLADNEY, P.97 & 141-GIA, uncle of David Clark Gladney above, as published by The Seven-Up Company... "Mr. Frank Y. Gladney, secretary-treasurer and member of the board of directors of The Seven-Up Company, died at his home in St. Louis, Oct. 28, 1961. Mr. Gladney was 84 years old and had continued his law practice and his daily visits to the 7-Up offices until 1960, when declining health forced him to restrict his activities. The immediate cause of death was aplastic anemia. Funeral services were held Oct. 30 in Central Presbyterian Church, where he had taught the men's Bible class for several years ... With Mr. C. L. Grigg and Mr. Edmund G. Ridgway, Mr. Gladney formed The Howdy Company which became The Seven-Up Company in 1935. His profound legal knowledge and wide experience in corporate management and finance served always in the guidance of the affairs of The Seven-Up Company. His addresses at 7-Up meetings were warmly acclaimed and long remembered for the sound and uncompromising principles he set forth, for the abiding confidence in 7-Up Developers he exemplified, and for the stirring vision of the 7-Up destiny which he made to fill the minds and the imagination of his listeners. His belief and his vision are engraved in the memories of all who knew him and drew strength from him."

Other very interesting published information on FRANKLIN YOUNG GLADNEY (Apr. 6, 1877 - Oct. 28, 1961), with photo, reads... FRANK Y. GLADNEY was born on a farm near Auburn, Missouri. He received his early education in a one-room school house; his high school education by studying at home for the examinations for a state certificate; his Missouri University education with the help of student jobs and scholarship aid; and his Columbia University law degree with tuition grants from the university and a weekend job as conductor on a Coney Island trolley car...He entered the practice of the law in St. Louis in 1902, and continued it for 58 years until illness reduced his vigor in 1960. His knowledge of patent law was prodigious and his book, Restraints of Trade in Patented Articles, clarified a confused tangle of conflicting decisions of the Supreme Court and the lower

Federal Courts. He was retained by some of the largest corporations in St. Louis, Boston and New York to represent them in cases which he argued before the Supreme Court of the United States ... During the 1930's he served as chairman of the American Citizenship Committee of the Bar Association of St. Louis, and in 1937 he set up an endowment fund through the Columbia University Alumni Federation to provide a dormitory room for a needy law student each year... In 1921 he joined with C. L. Grigg and Edmund G. Ridgway in the incorporation and capitalization of The Howdy Company, which had been started in the spring of 1920 as a co-partnership composed of Mr. Grigg and Mr. Ridgway. These three were officers and directors of the company through the 1920's and 1930's, the name being changed to The Seven-Up Company in 1936. Mr. Gladney was secretary-treasurer of the company at the time of his decease...To 7-Uppers Mr. Gladney will perhaps be best remembered for his stirring speeches at Developers' meetings. He always fussed when he was asked to appear on the program, and for days before the meeting he would go through a ritual of complaining that there was nothing he could say that had nt already been said. In the privacy of his study he made copious notes on blocks of the ruled yellow paper that served for the first drafts of his most famous briefs and other writings... When he came before the meeting, free of notes or script, he disdained the lectern and strode to the center of the stage, where a microphone had been hopefully placed. It was pure happenstance if he spoke to this instrument, however. He did nt like to "talk through that little augur hole," as he termed it, and he customarily paced back and forth as he warmed to his subject, occasionally slapping the top of the hapless mike for emphasis...His effect upon his audience was electric. He transmitted his conviction of the fundamentals for success in business, and the splendor of his vision of the future of 7-Up. The business fundamentals were well set forth in the prospectus he wrote for the formation of The Howdy Company in 1921: "Success in a selling enterprise requires: 1. An article of merit; that is to say, one for which there is some real durable demand; 2. Knowledge, skill and persistent industry in pushing it; and 3. The requisite capital to make effort fruitful." These principles applied as well to the growth and progress of 7-Up through the "knowledge, skill and persistent industry" of 7-Up Developers and The Seven-Up Company... His abiding thought of the future was a theme that ran through his speeches: "We can't know the future, and it is a wonderful thing that we can t... the reason we can't know the future is that we have TO MAKE the future. It does nt just happen; it is a result of our activity. Your view of the future will be decisively important in determining what that future shall be. never was a set of men better prepared, it seems to me, to take advantage of that enormous future expansion of business than the 7-Up Developers."... The vision shone forth in every speech he made to a 7-Up audience. His address to 900 men and women of the 7-Up world, at the First International Seven-Up Developers Meeting in St. Louis in 1946, concluded with these words: "If you will not permit yourselves to forget the formula for your success, and follow that formula regardless of your past accomplishments, then 7-Up has a greater future than any of us have yet foreseen. I still hope to see Mr. C. L. Grigg's great vision turned into a reality. For fifteen years I have seen it coming nearer every year. If only you Developers are fully alive to your opportunity, 7-Up will take its place where it belongs. And that is not third place or second place. It is elsewhere, and you know where."

- George, the above article makes me stop and think about the future for our family clan. Perhaps our activities today will make the future for our GIAFA from which other notable Gladney descendants will emerge. I too believe that it will be a result of our activity! Let me thank you again for sending all of the above family information and sharing it with us. Most probably on later pages of Gladney-Grams newsletters I will include the old will and testament of your great-great-great grandmother, Jane Strong Gladney, wife of Richard Gladney III, ref. P.3-59-115-117-GIA. Much of your material will be placed in our GIA Book of Remembrance. We will look forward to meeting you, your sister Mary Elizabeth, and others of the Missouri branch soon!

7-8-85 Letter from Mr. J. H. Warmoth, Clerk of Session, Bethel Associate Reformed Presbyterian Church, Zion Street, Winnsboro, SC 29180 (Rev. Jerry R. Wolff, Pastor) confirming that MRS. ALVA STEVENSON MACFIE of Winnsboro, a member of our GIAFA and a member of this church, would open the OLD BRICK CHURCH on Saturday, July 27, at 3:30 pm for our GIAFA excursion visit.

Mr. Warmoth enclosed some very interesting historical information on the Associate Reformed Presbyterian Church and the Old Brick Church building. Many in our Gladney family clan believe, it seems, that the movement of our very remote Gladney ancestors was from Scotland to Northern Ireland to America - for reasons of religion - their movement from Scotland to Northen Ireland having occurred perhaps in the 1600's or earlier. The following historical data which I want to share with you is most certainly "food for thought"...the widow JANE WILSON GLADNEY from County Antrim, Northern Ireland to colonial America in the 1700's - our Mother of Gladneys In America - was of the Reformed Presbytery (Covenanters):

"The Associate Reformed Presbyterian Church is the result of an organic union in America of the Associate Presbytery and the Reformed Presbytery (Covenanters), both of which were organized in Scotland by separating from the Established Presbyterian Church. Some pertinent historical dates and facts are as follows...

1560 - As part of the Reformation, the Scotch Church became the official church of Scotland and adopted the Westminster Confession and the Catechism as basic doctrine. During the following century, there was bitter dissension and persecution within the church principally over state control, disregard of the basic doctrines and form of church government. (Note by this Gladney-Gram writer...Many of these dissenting Scottish people, because of religious persecution in Scotland, settled in the northern part of Ireland during the 16th and 17th centuries. The persecution followed them into Ireland, so they chose to take the dangerous trip across the Atlantic to the New World. They were courageous in the face of many hardships. They valued their faith more than their lives and were earnest and unswerving in their devotion to their Covenanter and Reformed principles).

1688 - William III (William of Orange) upon ascending the throne reorganized the existing church into the Established Presbyterian
Church of Scotland, discontinued persecution, but many were still
dissatisfied with continued practices pertaining to church government
and disregard of basic doctrines, so in -

1733 - Under the leadership of Ebenezer Erskine, the Associate Presbytery was organized at Gairney Bridge, Scotland, separating from the Established Church. Then in -

1743 - The Covenanters who had for years dissented and organized themselves into societies formally organized the Reformed Presbytery. The Associate and Reformed Presbyteries grew, spread to North Ireland, then members immigrated to America where societies and churches organized throughout Pennsylvania, New York, Carolinas, and Georgia. Then in -

1758 - Associate Presbytery of Pennsylvania was organized.

1774 - Reformed Presbytery of Pennsylvania was organized. The

differences which kept these two bodies apart in Scotland and North Treland were less pronounced in America and following negotiations there was organized in -

1782 - The Associate Reformed Synod in Philadelphia which included churches located throughout Pennsylvania, New York, Ohio, Carolinas, and Georgia. As part of this Synod, there was organized in -

1790 - Associate Reformed Presbytery of Carolinas and Georgia at Long Cane, SC (Abbeville County). During the next twenty years the church grew and in 1802 it was decided to organize four Synods and one General Synod; consequently in -

1803 - The Associate Reformed Synod of the Carolinas was organized May 9 at BRICK CHURCH, Fairfield County, South Carolina. This, with the Synods of Pennsylvania, New York and Scioto, Ohio, organized the General Synod in 1804 with headquarters in Philadelphia. This General Synod organization continued until it was agreed that each Synod become independent and in 1822 the Synod of the Carolinas became the A.R. Synod of the South.

The Synods of Pennsylvania, New York, and Scioto, of the Associate Reformed Church and the Associate Church which did not go into the union of 1782, joined in 1858 to form the United Presbyterian Church. This denomination merged with the Presbyterian Church, U.S.A., in 1958 to form the United Presbyterian Church, U.S.A."

The OLD BRICK CHURCH (Ebenezer) in Fairfield County, S.C. is of special interest to our Gladney clan. So is the OLD ROCK CHURCH (Lebanon), now in ruins, with a number of early Gladney descendants buried in it's cemetery. Both are near the original colonial land grants to our immigrant ancestors. And so is the OLD ROCK HOUSE or PRESBYTERIAN MANSE built about 1784 which was the residence of Presbyterian pastors and their families. And, of course, the newer LEBANON PRESBYTERIAN CHURCH which replaced the Old Rock Church (Lebanon) a few miles away is meaningful to us because a number of later Gladney descendants are also buried there. Especially for those Gladney descendants who have not visited the OLD BRICK CHURCH and perhaps experienced a certain heartfelt feeling about our early ancestors, let this Gladney-Gram writer take you on a tour of this historical old church....

The OLD BRICK CHURCH on Little River was formerly called Ebenezer Meeting House. It was constructed in 1788 of brick which was made by members of the congregation...This is the second building of the Associate Reformed Society of Presbyterians of Ebenezer. The original meeting house, made of logs, had been built by Captain James Kincaid two miles west of this location sometime before the Revolutionary War...The early settlers of this section were Scotch-Irish people—Scottish people who, because of religious persecution in Scotland, settled in the northern part of Ireland during the 16th and 17th centuries. The persecution followed them into Ireland, so they chose to take the dangerous trip across the Atlantic to the New World. They were courageous in the face of many hardships. They valued their faith more than their lives and were earnest and unswerving in their devotion to their Covenanter and Reformed principles....In 1803 the Synod of the Carolinas was organized in this church—making a southern branch of the Associate Reformed Presbyterian Church. The Reverend James Rogers, a native of Ireland who was

educated at Glasgow University in Scotland, was the pastor of church and was chosen to serve as moderator of the first meets the Synod. The Rev. Rogers also conducted a school near Monti for young men. He is buried behind the church...For many year was a large congregation worshipping here-but migration to th the War between the States, and removal of many to the towns a cities has left the old church now without a congregation. It used only on special occasions - but it is considered a shrine A.R.P. Church...This building is included in the National Region Historic buildings. It is of simple, sturdy colonial style of the early up-country churches... Observe the use of the famou of the early up-country characters. plastering the outline of the steps. The window behind the pulpit was originally the door to that gallery. On the outside you will notice the door was converted into a window... The walls are brick and thick whe hand planed pews offered no comfort for about 12 inches thick. The hand planed pews offered no comfort for the worshippers but were sufficiently sturdy to support many generations of worshippers... The original pewter communion service is in safekeeping at the Bethel Associate Reformed Presbyterian Church in Winnsboro. Tokens were given by the Session of the church to the members worthy to take communion -- those who were living as good Christians... Opposite the narrow steps leading to the slave gallery is the incription of apology on the door frame which the Yankee soldier left after the troops of General Williams' 20th Corps had torn out the floor of the church in February 1865 to make a bridge over Little River for the continuation of their march on Winnsboro. The cemetery holds many interesting stones—several Revolutionary War soldiers, Civil War soldiers -- the grave of the first pastor, Rev. James Rogers. . The grave of Mary McMorries Kincaid is west of the church. The story of Mary's trip across the Atlantic as a child of twelve is an interesting legend. The ship's supply of food gave out and the travelers cast lots to see which member would be a sacrifice. When the lots were drawn, Mary's name appeared. They were appalled.

Mary was so beautiful and so young. They prayed and drew lots again. and again Mary's name appeared. They had a long night of prayer and on the morning a ship was sighted which came and furnished them supplies -- and Mary's life was spared. She came to Fairfield with her family and later married a Kincaid and became the ancestress of many Fairfield citizens dond as has edo that and Wavestly &

Traditionally, there has been strong religious faith and convictions within our Gladney family clan... A great heritage belongs to us!

GLADNEYS IN AMERICA 1985 REUNION WEEK FINALLY HERE!......

MONDAY, JULY 22, 1985 My 11-year old grandson, SETH RICHARD HARDIN, was not able to fly from California to Dallas and go to the reunion with me. At 5:00 am I was enroute from Waco, Tx. to Georgia and arrived at Birmingham, Ala. by nightfall...slept well. On Tuesday morning I left Interstate Hwy 20, driving south to Talledega (Talledega Co., Ala.) on to Lineville (Clay Co., Ala. where my grandmother was born) to Wedowee (Randolph Co., Ala. where my grandfather was born) then on over to Carrollton, Ga. to visit CECIL and POLLY GLADNEY. This area from which my grandparents departed for Texas in 1893 was of great interest to me. I reported that our Gladney-Grams are being received at nearly 300 addresses or households of Gladney descendants and expressed family appreciation for their exceptional interest and financial support. The minutes and treasurer's report were read by the secretary and treasurer, and approved.
